Purpose:

This grant program aims to support youth in Logan, Morgan, Washington, Yuma, Phillips and Sedgwick counties in their pursuit of agricultural learning and leadership through 4-H and FFA SAE projects. This is a one-time grant given to 4-H and/or FFA members to be used for costs associated with 4-H and FFA projects.

Eligibility:

Applicants must be a member of or be eligible to join 4-H or FFA for the upcoming program year (October - September for 4-H, academic year for FFA). Applicant must reside in Logan, Morgan, Washington, Yuma, Phillips, or Sedgwick county. Applicant's project must be a livestock or agricultural 4-H or FFA Supervised Agricultural Experience (SAE) project. Children or grandchildren of Premier Farm Credit employees and board members are not eligible to apply. **Past recipients will again be eligible for selection 2 years after they were first selected and only in a different project than the initial grant.**
